The India Global Leaders Scholarship is an exciting opportunity for high achieving students from India to further their business, economics or law studies at The University of Queensland (UQ).

Scholarship details

Awarded to students from India studying a business, economics or law undergraduate or postgraduate coursework program (excluding the MBA program).

Award value

- \$5000 to \$20,000 tuition fee scholarship. The final amount awarded to the successful applicants will be at the discretion of the selection committee.
- Priority access to exciting opportunities to develop your employability and leadership skills.
- Receive exclusive invitations to selected 'invite only' seminars, presentations and events throughout your studies.
- Join a network of Global Leaders Scholarship alumni upon graduation, and build on professional networks at home and abroad.

Application deadlines

30 November for Semester 1 commencement.
31 May for Semester 2 commencement.

Eligibility

- Citizens of India who normally reside in India, and are not already undertaking studies in Australia*. Those studying an English language course/program** in Australia are still eligible to apply.
- Students who have received an offer for a relevant undergraduate or postgraduate coursework program and who are commencing students at UQ (the opportunity is not open to currently enrolled UQ students or students studying at UQ on study abroad or exchange).
- The scholarships are awarded on the basis of academic excellence. High achieving students are encouraged to apply
- Students must not simultaneously hold another scholarship for tuition fees.

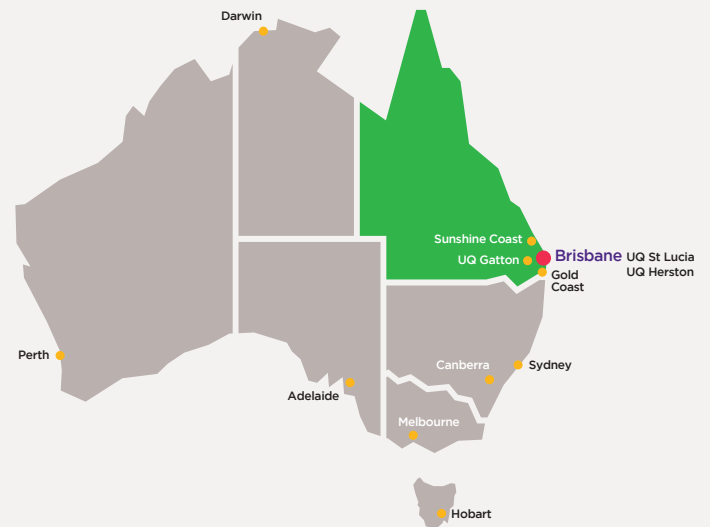
Welcome to Queensland
