

UQ Lifelong Learner Scheme Terms and Conditions for Domestic Students

(These Terms and Conditions outline the eligibility and process for the UQ Lifelong Learners scheme for domestic students enrolled in a postgraduate program at UQ on a full fee-paying basis.)

1. Definitions

In these Terms and Conditions –

Scheme means the UQ Lifelong Learner Scheme for domestic students.

Relevant program means any postgraduate coursework program at The University of Queensland with the exception of the following programs:

- Doctor of Clinical Dentistry, Doctor of Psychology, Doctor of Medicine, Doctor of Medicine (Ochsner), Doctor of Medicine (Provisional),
- Graduate Certificate in Business Administration, Graduate Diploma in Business Administration and Master of Business Administration programs.
- Master of Dietetics Studies, Master of Clinical Psychology, Master of Organisational Psychology, Master of Psychology, Master of Business Psychology, Master of Counselling, Master of Physiotherapy

UQ Alumnus means a student who has completed a program at Bachelor level or higher at UQ prior to commencing the relevant program, and in the case of graduates of coursework programs, has completed at least 16 units of study at UQ prior to commencing the relevant program.

2. Purpose

The purpose of the UQ Lifelong Learner Scheme is to recognise and reward UQ alumni returning to UQ to undertake postgraduate coursework studies in Semester 2, 2021 on a full-fee paying basis by reducing their fees.

3. Value and duration

- (1) The value of the Scheme is a 10% reduction in the tuition fees payable for the duration of the program.

4. Eligibility

- (1) An applicant is eligible for the Scheme, if the applicant:
 - (a) is a full-fee paying domestic student in accordance with the University's [Fee Policy](#);
 - (b) is commencing a Relevant Program at UQ in Semester 2, 2021;
 - (c) does not hold a Commonwealth Supported Place in the Relevant Program;
 - (d) is a UQ Alumnus.
- (2) This Scheme is only available to students commencing a Relevant Program in Semester 2, 2021, and cannot be deferred.
- (3) A recipient found guilty of misconduct after commencing studies in the Relevant Program will be deemed ineligible for the Scheme.
- (4) Other benefits and awards:
 - (a) A recipient may not receive a tuition fee reduction through this scheme in a study period if they receive another tuition fee reduction in the same study period.

5. Termination of UQ Lifelong Learner

- (1) The University will terminate the UQ Lifelong Learner:
 - (a) if the recipient does not enrol or remain enrolled in a relevant program in the proposed semester of commencement
 - (b) if the student commits misconduct.

6. Appeals Against Termination of UQ Lifelong Learner

- (1) Appeals regarding the termination of the UQ Lifelong Learner will be considered by the Academic Registrar in accordance with the University's [Student Grievance Resolution Policy](#).
