

Schedule C Alumnus Scholarships

E.S. Cornwall Memorial Scholarship

(The scholarship was established in 1956 as a memorial to Edward Satchwell Cornwall, general manager and director of the Southern Electric Authority of Queensland, by public subscriptions amounting to \$17,442 and a subsidy of \$17,324 by the Southern Electric Authority of Queensland.)

1. Definitions
In these rules—
'Dean' means the Executive Dean, Faculty of Engineering, Architecture and Information Technology
'scholarship' means an ES Cornwall scholarship
 2. Purpose
The scholarship is established to enable **graduates in Engineering of Queensland universities** to obtain special experience abroad in aspects of the electricity supply industry so that the industry in Australia may benefit by the knowledge and experience thus gained by them.
 3. Nature and value of scholarship
The scholarship is a living allowance of at least \$3,000 per month, tenable for a period of 9 to 18 months, as determined by the successful applicant's proposed program of work and/or study.
 4. Award of scholarship
The Senate may award 1 scholarship every 2 or 3 years to a graduate in Engineering of a Queensland university on the recommendation of the Dean.
 5. Eligibility for award
An applicant is eligible for the award of a scholarship if—
 - (a) the applicant submits an application for the scholarship to the Dean, by the closing date for applications; and
 - (b) on the date when the applicant submits the application, the applicant—
 - (i) is a graduate in Engineering of a Queensland university.
 6. Selection process
 - (1) The scholarship shall be awarded by the Senate on the recommendation of an Advisory Committee consisting of representatives of the following sectors of Queensland's electricity supply industry and The University of Queensland:
Electricity transmission;
Electricity distribution;
Generation or consulting engineering;
Electrical power equipment manufacturing;
The Faculty of Engineering, Information technology & Architecture;
Australian Power Institute.
- The Dean must rank the eligible applicants consecutively in order of merit, based on, for each applicant—
- (a) the merit of the applicant's proposed program of work and/or study, indicating how the scholarship amount would be spent to enable the applicant to participate in—

- (i) employment by a manufacturing or research organisation or by an electricity supply authority, or by 2 or more of such bodies in succession, the employment being for the most part in a responsible capacity in a field approved by the committee; or
- (ii) study for a higher degree; and
- (b) the quality of the proposed program of work and/or study prepared by the applicant; and
- (c) the quality of the applicant's performance in their previous studies.

(2) If the Dean is satisfied that at least 1 eligible applicant of sufficient merit to warrant the award of a scholarship, the Dean must recommend that a scholarship be awarded to the applicant with the highest ranking.

7. Conditions for scholarship

- (1) The recipient of a scholarship must provide quarterly reports, giving a general account of the work and/or study performed during the previous quarter and impressions gained thereby, during the tenure of the scholarship.
- (2) The recipient of a scholarship must provide a full report, suitable for circulation within the electricity supply industry, on the work and/or study performed during the tenure of the scholarship, within 3 months of the end of the scholarship.
- (3) The recipient of a scholarship must include in any publication or report that arises as a result of the work and/or study undertaken while the recipient holds the scholarship, a statement that the report was presented as a holder of the scholarship.
- (4) The University and any recipient of a scholarship must comply with any relevant terms and conditions not mentioned in these rules to which the University and the donor agree in writing.
- (5) Despite rule (4), if any of those terms or conditions is inconsistent with these rules, these rules prevail over those terms and conditions to the extent of the inconsistency.

A.E. Brooks Travelling Scholarship in Architecture

(Established in 1962 by a bequest to the University of approximately \$60,000 under the will of Arnold Edwin Brooks, Architect, of Brisbane, who died in 1958, and who in his will expressed the wish that half of the amount bequeathed, to be known in memory of his father as the Samuel Wood Brooks Fund, should be devoted to promoting the study of Literature and Political Economy, and half of it, to be known as the Arnold Edwin Brooks Fund, to promoting the study of Architecture.)

- 1. The object of the Scholarship is to enable **graduates in architecture** of the University of Queensland to obtain special experience abroad, so that the development of architecture in Queensland may benefit by the knowledge and experience gained by them.
- 2. The Scholarship shall be awarded annually by Senate, on the recommendation of the Head of School of Architecture.
- 3. The scholar shall take up the Scholarship within one year of the making of the award or at such later time as the Head of School may in special circumstances approve.
- 4. The Scholarship is open to any person who no more than 2 years before the year for which the award is made has graduated with the degree of Bachelor of Architecture or Master of Architecture from the University of Queensland.
- 5. The scholar shall pursue outside Australia for at least one year a program of work and study approved by the Head of School, including 2 of the following —
 - (a) study for a higher degree in architecture or a related program;
 - (b) experience in the practice of architecture or in a directly related field such as Regional and Town Planning;
 - (c) travel and study related to a particular field of architecture.

If the scholar studies for a higher degree the stay abroad should be extended for at least 6 months for the purpose of gaining experience or of travel and study as specified in paragraph (b) and (c) above.

- 6. The scholar is expected to return to Queensland not later than 3 years after the tenure of the Scholarship began. At the end of the first year of tenure of the Scholarship the scholar shall submit to the Head of School a comprehensive report on the experience. If thereafter the scholar remains abroad, on returning to Queensland a report shall be submitted on subsequent study, work experience and travel. If so requested by the Head of School, the scholar shall

give at least 1 lecture on special aspects of the study, work and travel undertaken to students of architecture at the University, or in lieu thereof give such other address or demonstration to students or other interested persons as the Head of School may approve.

7. In applying for an award of the Scholarship an applicant shall set out, to the satisfaction of the Head of School, a program of study, work and travel to be pursued.
8. The scholar shall be paid 80% of the value of the Scholarship prior to departure on an agreed study or work program and travel itinerary. The balance shall be paid on acceptance of a final report and fulfilment of any other commitments specified by the Head of School prior to the start of the Scholarship.
