



## EAIT International Award - Year 12 Terms and Conditions

This award is maintained by the Faculty of Engineering, Architecture, and Information Technology (EAIT) at The University of Queensland

### 1. Purpose

The purpose of the award is to encourage and reward international students studying Undergraduate Coursework programs administered by the EAIT Faculty.

### 2. Eligibility

The award is for international students applying to study at UQ on a full-time basis, including international students who have completed Year 12 overseas or in Australia. International students currently receiving fee sponsorship are ineligible for this scholarship. Only students with an unconditional offer are eligible to be considered.

### 3. Benefits

The total value of this award is \$10,000 to assist the recipient with expenses for the indicated degree program. A payment of \$5000 will be applied to the student's UQ account following the census date of their first two semesters of study, i.e. 31 March or 31 August.

### 4. Selection Process

- a) For the selection process applications will be assessed by the Faculty.
- b) Applications are assessed based on academic merit and suitability to the chosen program.
- c) The Personal Statement should include the reason why the student is seeking a scholarship and wanting to study their chosen program. It is also recommended students include information regarding any relevant extra-curricular activities, which may support their scholarship application.

### 5. Termination of Award

The scholarship will be terminated:-

- a) If, after due inquiry, the Faculty of Engineering, Architecture and Information Technology concludes that the student has not fulfilled obligations, or is not making satisfactory academic progress.
- b) If the student transfers to another program in UQ or withdraws from the University.
- c) Please note approval from the University is required if a student wishes to transfer or withdraw from the program. The University may require the student to repay the scholarship funds.
- d) If the student fails to maintain full-time study.
- e) Satisfactory academic progress means the recipient must maintain a GPA of at least 5 for each semester enrolled in their program. A recipient failing to maintain satisfactory academic progress must show cause why the scholarship should not be cancelled.

### 6. Obligations of Students

- a) Students are expected to fulfil all requirements associated with their student visa.
- b) Students shall diligently and to the best of their ability apply themselves to the successful completion of their degree.
- c) Students are required to conform to University regulations (including disciplinary provisions). Notification in writing to the Faculty is required if the student -
  - wishes to defer, transfer, or withdraw from the approved program
  - wishes to apply for an extension
  - is absent for any reason (other than recreation leave) for a period of 14 days or more from the place of study, except with prior approval of the Faculty.
- d) Students are required to assist as a student ambassador at two or more University events.

### 7. Health Insurance

Students are required to pay for their medical insurance through the Allianz OSHC scheme. Overseas Student Health Cover (OSHC) is a compulsory requirement of your student visa.
