



# UQ Lifelong Learner

## Terms and conditions for domestic students

(These Terms and Conditions outline the eligibility and process for the UQ Lifelong Learners scheme for domestic students enrolled in a postgraduate program at UQ on a full-fee paying basis.)

### 1. Definitions

In these Terms and Conditions:

**Scheme** means the UQ Lifelong Learner Scheme for domestic students.

**Fee Reduction** means the fee reduction offered through the Scheme.

**Relevant program** means any postgraduate coursework program at The University of Queensland with the exception of the following programs:

- Doctor of Clinical Dentistry
- Doctor of Medicine
- Doctor of Medicine (Ochsner)
- Doctor of Psychology
- Graduate Certificate in Business Administration
- Graduate Diploma in Business Administration
- Master of Business Psychology
- Master of Clinical Psychology
- Master of Physiotherapy Studies
- Master of Audiology Studies
- Master of Speech Pathology Studies
- Master of Occupational Therapy Studies
- Master of Counselling
- Master of Dietetics Studies
- Master of Organisational Psychology
- Master of Physiotherapy
- Master of Psychology
- Graduate Certificate in Business Administration
- Graduate Diploma in Business Administration
- Master of Business Administration
- Master of Biostatistics
- Graduate Diploma in Biostatistics
- Graduate Certificate in Biostatistics.

**Relevant Semester** means the semester of commencement outlined in the formal notification of eligibility.



**UQ Alumnus** means a student who has completed a program at Bachelor level or higher at UQ prior to commencing a Relevant Program, and in the case of graduates of coursework programs, has completed at least 16 units of study at UQ prior to commencing the Relevant Program.

## 2. Purpose

The purpose of the UQ Lifelong Learner Scheme is to recognise and reward UQ alumni returning to UQ to undertake postgraduate coursework studies on a full-fee paying basis by reducing their fees.

## 3. Value and duration

- (1) This scheme provides a 10% reduction in the tuition fees in each semester of enrolment in the Relevant Program.

## 4. Eligibility

- (1) An applicant is eligible for the Scheme, if the applicant:
  - (a) is a UQ Alumnus;
  - (b) is a full-fee paying domestic student in accordance with the University's [Fee Policy](#);
  - (c) commences a Relevant Program at UQ in the Relevant Semester; and
  - (d) does not hold a Commonwealth Supported Place in the Relevant Program.
- (2) Other benefits and awards:
  - (a) A recipient may not receive a tuition fee reduction through this scheme in a study period if they receive another tuition fee reduction in the same study period.

## 5. Termination

- (1) The University will terminate the Fee Reduction:
  - (a) if the recipient does not commence a Relevant Program in the Relevant Semester; or
  - (b) if the student commits misconduct.

## 6. Appeals against termination

- (1) Appeals regarding the termination of the UQ Lifelong Learner scheme will be considered by the Academic Registrar in accordance with the University's [Student Grievance Resolution Policy](#).
