



# Rt Hon Doug Anthony AC, CH, FTSE Scholarship

(Established in 2018 by the Rt Hon Doug Anthony AC, CH, FTSE to support students at the School of Agriculture and Food Sustainability or UQ Skills. Mr Anthony is an alumni of Gatton College (LAWES) Qld Diploma in Agriculture (1948) and recipient of the 1985 Council Gold Medal.)

## 1. Purpose

The purpose of the Scholarship is to provide assistance to School of Agriculture and Food Sustainability or UQ Skills students, who, because of their financial circumstances, might otherwise be unable to undertake full-time study.

## 2. Definitions

In these rules –

**Approved Program** means any undergraduate program offered at the School of Agriculture and Food Sustainability or any diploma-level program in agriculture offered by UQ Skills.

**Associate Dean** means the Associate Dean (Academic), Faculty of Science.

**Scholarship** means The Rt Hon Doug Anthony AC, CH, FTSE, Scholarship.

**UQ Skills** means the Registered Training Organisation (RTO #1511) within The University of Queensland.

## 3. Award and value of scholarship

- (1) One or more scholarships may be awarded annually on the recommendation of the Associate Dean, in consultation with the selection committee.
- (2) The value of a scholarship is \$6,000 but limited to the annual income of the fund.

## 4. Eligibility for award

An applicant is eligible for the Scholarship if the applicant –

- (a) applies for the scholarship by the closing date for applications; and
- (b) is studying full-time at the School of Agriculture and Food Sustainability or UQ Skills; and
- (c) is currently enrolled full-time in the Approved Program.

## 5. Selection of award

For the selection process, the Associate Dean must establish a selection committee, comprising:

- (a) the Associate Dean, or nominee, as chair of the committee;
- (b) at least one academic staff member who is currently teaching in an Approved Program; and
- (c) at least one additional staff member from the Faculty of Science

The scholarship is awarded at the discretion of the Associate Dean, on the recommendation of the selection committee, to the applicant or applicants on the basis of –

- (a) financial need;
- (b) past or current academic achievement;
- (c) strength of personal statement included with application; and
- (d) any other matter that the Associate Dean considers to be relevant to the applicant's success in their studies.

Preference will be given to UQ Skills students enrolled in any of the following:

- Diploma of Agribusiness Management AHC51422; or
- Diploma of Agribusiness Management AHC51422/Diploma of Agriculture AHC50116 (Dual program); or

## 6. Conditions for scholarship

- (1) The recipient may hold the scholarship for one year subject to the recipient remaining enrolled as a full-time student in an approved program.
- (2) If the recipient fails to satisfy rule 6(1) the recipient must show cause to the Associate Dean, why the scholarship should not be cancelled.

## 7. Termination of scholarship

The University may terminate a Scholarship -

- (a) if the recipient does not show cause to the reasonable satisfaction of the University as provided for in rule 6(2); or
- (b) if the student commits serious misconduct.
